

TRAVEL AGREEMENT

1. ACCEPTANCE OF THE CONTRACT

Upon purchase of the hunting or fishing trip, these terms and conditions become a binding contract between the Purchaser and Sports Resorts International, Inc. (SRI). Acceptance of this contract occurs when the deposit and signed agreement are received by SRI at its office. Purchaser represents by tender of payment and signed Agreement that the itinerary and these terms and conditions have been reviewed and that it meets Purchaser's expectations and request. The contract is to be performed in Harris County, Texas.

2. DEFINITIONS

- a. SRI and its affiliates are acting only in the capacity of agent in all matters of transportation and trip operation.
- b. The Hunting or Fishing Trip purchased from SRI consists of the itinerary prepared by SRI. The itinerary is the written schedule listing scheduled daily activities and travel services purchased. In the event of a difference between information contained in the brochure and that contained in the itinerary, the language of the itinerary shall control.
- c. Confirmation of Travel Arrangements. Travel Arrangements are not confirmed until SRI has received the required deposits and Purchaser has received formal confirmation from SRI.
- d. Transfer refers to transportation from one location to another, generally between the airport and the lodge and, unless otherwise stated on the itinerary, refers to a seat in a van, bus, car, or other vehicle. Determination of the appropriateness of vehicles shall be determined by the provider of the service.

3. RESERVATIONS AND PAYMENT

- a. To reserve space on any trip, we require a deposit of \$250 per person for fishing trips and a 50% deposit for hunting trips due within 10 days of the reservation. Early reservations are essential to guarantee your accommodations on the date you wish to travel.
- b. Final payment is due 60 days prior to the departure. If this final installment is not paid when due, SRI reserves the right to treat the reservation as cancelled. Payment is via check, money order or bank transfer only.
- c. Reservations made within 60 days of the departure require full payment, plus any additional charges for expenses incurred due to special mailing, fax charges, etc.

4. PARTICIPATION

- a. Purchaser is responsible for selecting a trip appropriate to his or her health, physical abilities and interests. The right is reserved to decline to accept or retain a person as a tour member for any reason which affects the operation of the tour or the rights and welfare or enjoyment of the other tour members, and a refund of recoverable land tour services is the limit of SRI's liability.
- b. Purchaser is responsible for obtaining necessary travel documents for areas visited.

5. PRICE OF THE HUNTING OR FISHING TRIP

The hunting or fishing trip price includes all the pre-paid travel services represented by the confirmation letter provided to the Purchaser, together with the charges by SRI for its services in preparing the itinerary.

- a. All prices are accurate and available at the time of publication, and include charges for planning, operation and servicing the package. Prices do not include airfare unless otherwise stated.
- b. Until the required deposit is received from Purchaser, prices are subject to change, due to fluctuations in tariffs, exchange rates and other factors beyond SRI's control. If the group falls below the minimum passenger requirement, the trip is subject to cancellation or re-pricing.

- c. SRI has no obligation to provide Purchaser with any information concerning the costs utilized in establishing the price of the hunting or fishing trip, either before, during or after the trip is completed.
- d. Price does not include charges for passports, visas, inoculations, laundry, excess baggage charges, trip cancellation or interruption, accident and baggage insurance, or transportation not included in the itinerary, optional tours, items of a personal nature, items not specifically listed as included and international departure taxes.

6. CANCELLATION POLICY

A \$250 nonrefundable deposit for fishing trips and a 50% deposit for hunting trips is due within ten (10) days of reservation with the balance due sixty (60) days prior to the trip. Deposits and final payments are non-refundable. We strongly advise you to purchase trip insurance soon after registering for a trip. In the event that you must cancel your trip due to illness, family crisis or other emergency, this insurance reimburses you for nonrefundable trip costs. This insurance also provides for limited accident and baggage coverage. You may purchase trip insurance through your travel agent or obtain insurance forms direct from SRI.

7. REFUNDS

- a. Deposits and final payments are non-refundable.
- b. No refunds are given for any unused pre-paid service included in the hunting or fishing package or any changes made in the itinerary while enroute, including changes in hotel accommodations, excursions, and transportation services. Charges included for services provided by SRI are not subject to refund.

8. CHANGES IN ITINERARY BY SRI

SRI reserves the right to:

- a. Make changes or cancellations in services where such changes are made necessary by circumstances beyond SRI's control, including changing carriers and substituting similar hotel accommodations for those designated in the itinerary.
- b. Cancel any trip due to inadequate signup which makes the trip economically infeasible to operate. In such cases, a full refund of the cancelled trip cost is the limit of SRI's liability.

9. WARRANTY DISCLAIMER

No guarantees or warranties, express or implied, are made that the hunting and fishing trip will meet all of the traveler's expectations, specifically regarding weather or hunting and fishing conditions or productiveness.

10. AIRFARE CONSIDERATIONS

SRI cannot be responsible for any part of the hunting or fishing trip that might be missed because of cancellations or delays of commercial airlines. SRI will make reasonable effort to assist the Purchaser in transferring to the destination, but Purchaser is responsible for any additional expenses incurred in making this transfer. The passenger tickets shall constitute the sole contract between the airlines and the purchaser of these tickets and/or passenger. All baggage shall be carried at participant's own risk.

11. RELEASE

SRI, its affiliates and all cooperating airlines and agencies act only in the capacity of agents in all matters of transportation and trip operation, and their liability is limited to the terms of the airline tickets and land accommodation contracts. Group organizers, purchasers, travelers and tour participants, individually and jointly, release SRI from any and all liability and responsibility, known or unknown, present or future, for any and all loss, injury to person, expenses, direct or consequential damages, damage to property, or accident, or which may be the result of any delay or change of itinerary, or irregularity connected with the trip purchased, including but not limited

to, acts of God, transportation problems, fire, machinery or equipment malfunction or failure, government actions, wars, civil disturbances, labor disputes, riots, thefts, sickness, negligence by any service suppliers in the trip package, or weather. This release is binding upon group organizers, purchasers, tour participants, travelers, their representatives, heirs and assigns.

12. CHOICE OF LAW AND VENUE

All questions of law in any action based upon any claim of breach of this agreement shall be determined in accordance with the laws of the State of Texas. Any action brought by either party based on any claim arising under or as a result of this contract or based on the hunting or fishing trip of which it is a part, shall be brought in a court of competent jurisdiction in Harris County, Texas.
